TYPES OF IP

Trademark

- It offers the possibility to identify products on the market.
- It's a tool for conquering new markets.
- It provides protection against competition (prohibiting commercial acts under the same trademark).

Invention patent

- It is a tool to protect a technical solution.
- A way of protection against competition (use only with the owner's authorization).

Industrial design/model

- This protects the new design of a product.
- It's a way to prohibit competitors from using a particular design without the owner's authorization.

Copyright and related rights

- The author can decide when the work will be made public.
- Also, he can retract it, if necessary.

1. Promoting the need for intellectual property protection

- Ensuring intellectual property protection through various forms of registration at national offices (OSIM, ORDA) and internationally (WIPO, EUIPO, EPO, US Copyright Office, Benelux Office).
- Drafting infringement notices, oppositions before OSIM, appeals before OSIM and representation in court if necessary.



← 6. Transfer of IP rights

- Creating and developing a database (portfolio of IP clients/suppliers).
- Initiating and mediating transactions for attracted IP demand and supply, as appropriate.
- Specialized legal assistance in trading intellectual property rights.
- · Providing a platform for mediating intellectual property rights, in agreed situations and after a procedure established between partners and with the clients' consent.
